## **Rules and Regulations**

### **Saturday's Events**

#### **Crosscut Events**

Each team will make two cuts through the cant provided. The contestants will have 6" in which to make the cuts. The cant may be brushed and marked. The judge will handle any equipment problems. Time will on go and stops when the last acceptable slab hits the ground.

#### **Log Roll**

All contestants will use the same log. The log will be rolled 50 feet with two stakes set at each end. The stakes will be set apart one foot less than the log is long. Cant hooks and peavys of any kind can be used. The log must be touching both pins at the start, be rolled and touch both pins at the other end of the course, and rolled to starting pins and touch both pins. Maneuvering the log with contestant's bodies will result in disqualification.

#### **Axe throw**

Anyone over 13 can compete. Axe head weight must be at least 2 pounds and have a handle at least 24 inches. Axes will be thrown a minimum of 20 feet. The target center will be five feet above the ground. The bulls-eye will be 6 inches in diameter. The axe must stick in the target until the judge tells the contestant to remove it. Two practice throws and three scored throws are allowed in no particular order. Contestant must tell judge before throw if it is to be a practice throw. Each contestant will be allowed five minutes to complete throws.

#### **Chopping Events**

Anyone over 18 can compete. The block may be marked in any way that does not cut into the wood. Time begins when the axe hits the block and ends when the block is severed (or when the severed half hits the ground).

#### **One Man Bucking**

Anyone over 18 can compete. A single sawyer uses a one-man bucking saw to cut through an 18-inch diameter log. Free end of saw must be clear of any handle or weight. Starting cut no more than a half-inch deep; to set the teeth of the saw are allowed. Timing begins on the starter's signal and ends when the block is severed. Cuts must be a complete disk. Cut will be within 2" from end of log.

#### **Spring Board**

Anyone over 18 can compete. The block may be marked in any way that does not cut into the wood. Time begins when the axe hits the wood and ends when the severed half of the block hits the ground. No hanging devices on boards. No test holes before the competition. The block must be cut from two sides.

#### **Hot Saws**

Anyone over 18 can compete. Chainsaws can be of any type of saw with any type of engine and can be run on any type of fuel (gas or alcohol). Contestants must wear protective eye and ear wear and safety chaps. Each contestant will make three cuts in a 6" pre-measured cant (which will be supplied). Timing will begin when the Judge gives the "go" signal and will end with the last cut through.

### **Sunday's Event**

#### **Chainsaw Obstacle Course**

Anyone over 18 can compete. Contestants will run through a series of precision cuts and end with the falling of a 20' pole. Complete instructions will be given to the contestants the day of the event. Contestants must wear protective eye and ear wear, safety chaps and work boots. The event will begin when the Judge gives the "go" signal and will end when the participant activates the chain break after the felling of the pole. The event is scored by timing and accuracy.

Our best efforts will be to meet your size request. Remember that the registration deadline is September 16, 2011. Event confirmations will be sent to e-mail addresses that are marked on the registrations. Please Print Clearly.

The registration table will open at 8:15 am on Saturday and 9:30 am on Sunday. You will need to "sign in" as soon as you arrive. Changes to your entries can be made if wood is available. Sorry, but no refunds will be allowed.

Entry fee for each competition still remains at \$5 per person. Please mark your partner's name on your registration form for "Log Rolling", "Cross Cut Saw" and "Jack and Jill Cross Cut". For the "Spring Board" event, please note if you are right or left handed. Our best efforts will be made to help competitors find partners for any competition. I will be glad to share information on who needs partners with other competitors. Just put "Partner needed" in the space for the name.

Enclosed with this letter is a free gate pass to use for your entry into the fairgrounds. It identifies you as a Lumberjack Competitor and will allow you access to the event arena. You may copy off as many as you need for you and your group. Please call or e-mail me or call the chamber office at 570-482-4088 if you have any questions concerning this event.
